Julie Wagner presented a report on FY 21-22 BHCVB Initiatives, results, a proposed work plan for FY 22-23 and a report on the 2022 BOLD Summer Marketing plan.

The Liaisons supported the request to the full City Council on May 24, 2022 for \$4,229,470 funding for the work plan and for the BHCVB rent increase of an additional \$32,823.04 for a total of \$4,262,293.04.

Will also request \$150,000 from FY 20-21 unused TOT dollars for the newly designed 2022 BOLD Street Pole Banners.
